Background

- ► The Formation of AfDAN was necessitated by an urgent need to establish an effective Pan-African-Climate Finance Network
- ► Agreed by African countries in 2015, in Alexandria Egypt and re-affirmed and integrated into the UNFCCC Framework during COP 23-Fiji in Bonn Germany in 2017
- ► AfDAN was officially launched during COP 27 in Sharm El-Sheikh, Egypt
- Founders African NDAs; Pan African Climate Justice (PACJA); and United Cities and Local Governments of Africa (UCLG Africa)
- It is aimed at mainly supporting African Countries through:
 - National Designated Authorities (NDAs),
 - Direct Access Entities (DAEs), and
 - Focal Points (FPs)
 - Civil Society Organizations
 - Private sector operatives

Objectives of AfDAN

▶ The main objectives of the Network are to:

- Accelerate mobilization of climate finance for adaptation and resilience building in all African Countries;
- Enhance ease of access to green/climate finance in Africa in a predictable, scalable and sustainable manner;
- Prioritize financing of locally led adaptation, resilience and mitigation actions especially in rural and urban areas;
- Share experiences and best practices from African Countries;
- Strengthen South-South-North partnerships and collaborations;
- Build local capacities in Africa-Africa by Africa

Involvement of African Countries

All African Countries are eligible and required to join the platform

Coordination is by NDAs/Focal Points-at the National level
& Secretariat at the Continental level

- Support access to GCF readiness funding

Decision on AfDAN during the Assembly of the Union, 37th Ordinary Session 17th February 2024 Addis Ababa, Ethiopia

► CAHOSCC Decision (31) acknowledged the role of Africa Green Climate Finance National Designated Authorities Network (AfDAN) is playing in bringing African Countries together to build their capacity to accelerate, ease of access and enhanced mobilization of climate finance at scale especially for adaptation and resilience building at the local levels.

Challenges

- Countries are slow to identify their representatives to the network
- Political goodwill is needed
- High staff turn-over in NDAs
- Non-utilization of GCF readiness funds -PPF by countries
- Lack of capacity to develop bankable proposals
- Slow disbursement of funds
- Interference from North-north countries

Milestones

- GCF has recognized and endorsed AfDAN as a delivery partner
- Supporting regional readiness program towards implementation of Building Climate Resilience of the Urban Poor (BCRUP) in the African context
- > 11 letters of No Objection so far received and commitment is strong from the remaining pilot countries
- Successful consultative meeting with UNECA, UCLG Africa and PACJA on operationalization of 37th ordinary session of CAHOSCC Decision 31 on AfDAN in Addis Ababa held on 6th August 2024
- Successful AfDAN and BCRUP focal points meeting 22-23 August, 2024 in Nairobi

Accelerating Access to Climate Finance-22-23 August 2024 in Nairobi- Major Outcomes

- Strengthened support for establishment and operation of AfDAN with its Headquarters in Nairobi
- Commitment to leverage climate finance to support locally led actions
- Support for the implementation of BCRUP initiative

Africa is negotiating climate finance from a position of strength, emphasizing its significant contributions to global climate action and vast resources critical to the global energy transition.

Adaptation finance for Africa must be increased and prioritized

Africa strongly advocates for the prioritization of grant-based financing rather than loans, especially for adaptation projects

There is lack of transparency in climate change reporting, there must be a distinction between climate-specific finance and broader development assistance where the former is over and above the latter

- Finalization of the hosting agreement for AfDAN by Ministry of Foreign and Diaspora Affairs
- 5-Year AfDaN Strategic Plan Development Process
