- I would like to take this opportunity to commend and congratulate the leadership of Burundi
  and in particular, the Ministry of Finance, Budge and Digital Economy for the phenomenal
  coordination and collaboration that has lead us to this point. You have made considerable
  effort to bring together all stakeholders necessary to develop this strategy, a feat not to be
  taken lightly.
- We would also like to give a special thanks to our key implementation partners, the AUC
  as lead by Madam. Souhila Amazouz, the AUDA-NEPAD and UNECA as lead by Dr.

- On the continent and within the region, Burundi remains an integral player in shaping digital realities, as evidenced by the considerable contribution and consistent participation in the development of the EAC Data Governance Policy Framework, which was validated in

Kigali, Rwanda in October 2024 and is set to be adopted at the next EAC Heads of State Summit.

- Locally, we are delighted to hear the efforts being made to enact a Data Protection and Privacy Law. This development is highly anticipated as it will mean regionally and continentally Burundi will now further the principles espoused under the African Union Data Policy Framework and most importantly move closer to implementing the Malabo Convention.
- As GIZ African Union we firmly believe in a future where the use of data is done fairly, inclusively and securely. We remain committed to Burundi in its efforts to build a resilient and prosperous data governance ecosystem harmonised with the African Union Data Policy Framework.
- Through the Data Governance in Africa Initiative, the EU, alongside Germany, Belgium, Estonia, Finland and France, has committed a total of 59 million EUR to this cause. The initiative supports the harmonisation of data policies on the continent and strengthens the foundation for data-driven societies and economies. The initiative is implemented through three key focus areas:
  - Data Policy which supports the development of harmonised data governance policy frameworks;
  - ii. Data value Creation which unlocks the potential for data-driven value creation;
  - iii. Data Infrastructure which supports investments in green and secure data infrastructure.
- Through this initiative, we seek to maximise secure cross-border data flows through strengthened coordination, which will enable a more vibrant and equitable data economy across Africa.
- At the same time, we recognise the importance of strong and diverse partnerships. Public, private, civil society, and academic institutions all have a role to play. The co-creation of
