## Information note on the Bureau of the Committee on Social Policy, Poverty and Gender

- 1. The Committee on Social Policy, Poverty and Gender of the Economic Commission for Africa (ECA) was preceded by the following former committees:
  - (a) Committee on Women in Development (1979–2013);
  - (b) Committee on Human and Social Development (2009–2013);
  - (c) Committee on Gender and Social Development (2013–2019).
- 2. In 2019, following the reform undertaken by ECA in line with the wider reform carried out by the Secretariat of the United Nations, the Committee on Gender and Social Development was renamed the Committee on Social Policy, Poverty and Gender. However, the session numbering of the Committee on Gender and Social Development was maintained.
- 3. In 2025, the sixth session of the Committee will be held from 26 to 28 November 2025, under the theme "From informal employment to sustainable livelihoods: emerging technologies as pathways for an equitable transition".
- 4. In paragraph 18A.45 of the proposed programme budget for the biennium 2014–2015 (A/68/6 (Sect. 18)), the Committee on Gender and Social Development as the Committee on Social Policy, Poverty and Gender was formerly known was designated as "an advisory forum of experts and policymakers" the role of which was "to provide guidance to the Commission in its work of promoting equitable and inclusive human and social development in Africa, with particular focus on gender, employment, population and youth development, social protection and urbanization". It was further explained that, during its biennial meetings, the Committee "reviews follow-up activities pertaining to global conferences and regional action programmes in the areas of social development, including the global and regional platforms for action on the advancement of women" and "reviews major trends and issues of regional interest regarding human and social development".
- 5. The Bureau of the Committee serves:
- (a) To provide guidance and expert opinion on the priorities and activities of ECA;
  - (b) To review the past activities and future programmes of ECA;

- (c) To provide recommendations to strengthen the programmes of ECA, with a view to better serving its members and the regional economic communities;
- (d) To provide policy guidance to ensure that ECA activities are relevant to meeting the region's development needs and addressing its development challenges;
- (e) To advise on priorities for the implementation and review of regional and international policy agendas in relation to the work of ECA;
- (f) To provide direction on ECA partnerships with the African Union Commission, the African Development Bank and development partners.
- 6. The present note serves as input for the election of the Bureau of the Committee. The memberships of previous bureaux of related committees are listed in tables 1 to 4, for consideration by members of the Bureau during the election process.
